CITY FEES AND CHARGES

I. Policy

To facilitate administration of City fees and charges, all City fees have been consolidated into one source document (attached). The City has a process for automatic adjustment of fees based on changes in factors appropriate to the different fees. This process helps ensure cost effective provision of City services and adequate cost recovery.

II. Procedure

A. Responsibility

1. Finance Manager

The Finance Manager has primary responsibility for monitoring City fees and charges, communicating any changes to concerned staff, and ensuring that appropriate adjustments are made when needed.

2. Division Managers

Division managers are responsible for ensuring all concerned employees are aware of current fees and charges and are collecting appropriate fees from customers. Division managers shall inform the Finance Manager of any changes in City operations affecting recovery rates or changes in fee adjustment factors that could result in adjustments to City fees.

B. Adjusting Fees and Charges

As specified by City policy (Council Resolution 104-99), all City fees, charges and rates are reviewed annually to determine if they should be adjusted. The Finance Manager shall act as the lead staff member for the review process.

1. As part of the budget process, Finance Division staff shall review fee adjustment factors. If changes in the factors indicate adjustment is appropriate, the fees shall be changed beginning January 1 of the next year.
2. All planned fee adjustments shall be discussed with appropriate staff in concerned divisions before being implemented.

CITY OF RICHLAND 2017 CITY FEE SCHEDULE

Following is a schedule summarizing City user fees and charges. In most cases, the column headings are self-explanatory, but for those headings that may not be completely clear, explanations appear below.

2017 Fee: The fee to be charged during 2017. In most cases, fee adjustments are based on adjustment factors approved by Council in 1999 – noted in the Adjustment Factor column on the schedule.

Adjustment Factor: The factor on which automatic fee adjustments are based. Levels to which fees are rounded up or down when adjusted are indicated. Fees and charges are subject to possible adjustment every January, as appropriate. As part of the budget process, information on fees (including CPI data) is collected during the summer so, if necessary, fees may be adjusted at the beginning of the next fiscal year.

- A Cost of service study by independent third party. The method customarily used to determine utility rates and charges. For utility rates and charges, the study will need to determine that recovery is sufficient to ensure that bond covenants are met.
- B Cost of outside instructors, materials and supplies, plus 30%. The basis on which Richland’s recreation fees have customarily been determined.
- C Annual percent change in consumer price index – Seattle urban wage and clerical workers (CPI-W) July through June.
- F Construction valuations published annually in “Building Safety Journal.” The fee basis is already established by City ordinance.
- H Survey of the market and the market average.
- I Subject to negotiated contract. For fees, charges and penalties applied to the cable television system provider established by the cable television charter.
- K Percent change in bank charge for insufficient funds check. Links change in City charge to changes in financial institution charges.
- L Fees are adjusted within established ranges at discretion of contract golf professional to maintain competitive position.
- M Based on 70% of State of Washington fee for industrial discharge, for industrial users per WAC 173-224.
- N Fees are based on the historical averages for service projects. Fees are adjusted to reflect current material cost, equipment costs and labor associated with the cost elements of the service.
- O Fees are based on current Richland Municipal Code as enacted by Ordinance or the Revised Code of Washington (RCW).

NEW AND MODIFIED PROGRAM FEES: As new programs are introduced, or current programs modified, staff will ensure cost recovery effectiveness by implementing necessary user fees and charges not to exceed actual costs, subject to approval by Council
